

ANNUAL PARKING AND ENFORCEMENT REPORT FOR THE PERIOD 2020/21

1. INTRODUCTION

1.1 The information contained in this report is in accordance with section 55 of the Road Traffic Act 1984 as amended by Traffic Management Act 2004.

2. BACKGROUND

- 2.1 The District Council operates over 50 car parks with over 6000 spaces. These are managed under the regulations set out in the 'District of New Forest (Off Street Parking Places) Order 2005'. A copy of the Order, car park locations and charges can be found on the Council's web site (www.newforest.gov.uk/parking).
- 2.2 The District covers an area of approximately 290 square miles with a resident population of 173,000. We now have an estimated 15 million visitors annually and a high percentage of these visitors will make use of the Council's pay and display car parks during their visits. Hampshire County Council is responsible for the enforcement of on-street Traffic Regulation Orders. This includes enforcement of single and double yellow lines, limited waiting bays, loading bays, motor-cycle bays, taxi ranks, bus stop clearways, pedestrian crossings and on-street disabled bays.

5. THE TRAFFIC PENALTY TRIBUNAL (TPT)

- 5.1 The Traffic Penalty Tribunal provides an independent judicial process for the hearing of appeals against the issue of Penalty Charge Notices. In this financial year 1 appeal was lodged relating to a PCN issued by New Forest District Council. This resulted in:

6. CONCLUSION

- 6.1 The number of PCNs issued in 2020/21 was less than the previous year. This was partially due to the change in patrol patterns in advance of the termination of the agency agreement and the impact of the Covid-19 global pandemic on people working from home and people following government guidance to stay at home.
- 6.2 There has been an adjustment to the split of employee costs to other services the enforcement team supply which overall means with the reduction in the number of PCN's issued off-street that the overall deficit in the enforcement account remains similar to the previous year. With Covid restrictions now easing it is anticipated that this deficit will reduce in the following year.
- 6.3 63% of all challenges and representations received resulted in Penalty Charge Notices (PCN's) being cancelled. This number was significantly higher due to the impact of Covid on people's ability to return to their parked vehicles due to the need to self-isolate and hospital admissions.
