- Sacks should be securely tied and left in plain sight on day of collection.
- Please flat-pack your cardboard and tie into bundles or pack into a single large box. A white and red business waste recycling sticker must be attached to each bundle or box.
- **Please note:** we do not have a wheeled bin service for general business waste. However, if you wish to place your green sacks in an 80 litre dustbin with a lid we will remove them.

Depending on the size and needs of your business there are various options available. We can collect from your business weekly, fortnightly or monthly. A flexible 'pay as you throw' service is available for businesses based in the tourism industry and for smaller traders.

What we collect

General business waste

Recyclable business waste

- ✓ Paper and card
- ✓ Tins, cans and aerosols
- ✓ Plastic bottles
- ✓ Glass

General business waste is collected in green sacks and recyclable business waste is collected in clear sacks with red print, or alternatively we have wheeled bins for larger volumes of recycling. Glass is collected separately from other recyclable business waste in wheeled bins.

Green business waste sacks, clear recycling sacks and white and red business waste recycling stickers can be purchased from our information offices.

To purchase business waste sacks and stickers you must be a New Forest District Council business waste customer and have completed a Duty of Care Waste Transfer note.

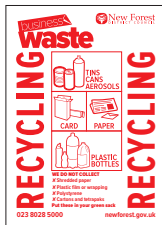
Collection guidelines 2021/22

New Forest District Council (NFDC) has recently reviewed the Business Waste Collection service we provide and have updated our procedures. Please adhere to the following guidelines below when putting your business waste out for collection at the kerbside:

Recycling

We provide clear sacks with red print for collection of recycling.

- Please put your recycling in the NFDC clear business waste recycling sacks and tie securely.
- Any cardboard boxes should be bundled together securely. Please affix a white and red NFDC business waste recycling sticker to each bundle.
 - Bundles must not exceed 7kg in weight.
 - Bundles larger than 2ft square will not be accepted.



General waste

- Please put your non-recyclable business waste material in the NFDC green business waste sacks and tie securely, to prevent spillage.
 - Sack must not exceed 7kg in weight.
- General business waste must be presented in an NFDC green business waste sack. We will not collect black or other coloured sacks containing general business waste.
- You may double bag your general business waste but the external sack must be an NFDC green business waste sack.
