PROVISIONS RELATING TO DELEGATIONS TO OFFICERS FUNCTIONS WHICH ARE THE RESPONSIBILITY OF THE COUNCIL

- (a) Without prejudice to the specific delegations to any officer, the Chief Executive and Executive Heads, or Chief Planning Officer are hereby authorised to make such decisions and initiate such actions as they may deem necessary in the interests of the Council's functions and services.
- (b) Delegation to officers shall be without prejudice to the rights and powers of the Council, Committee, or any Sub-Committee of a Committee at any time to decide upon any matter.
- (c) In exercising powers, officers:-
 - (i) shall comply with the Standing Orders and Financial Regulations of the Council;
- (ii) may authorise expenditure only in accordance with approved estimates which does not require a loan sanction or approval which has not been authorised or received;
- (iii) shall comply with approved policies, schemes or directions, where they exist; of the Council or any of its Committees; and
 - (iv) shall consult with the appropriate professional or technical officer of the Council.
- (d) Delegated powers of the Chief Executive, or Executive Heads, or Chief Planning Officer may be exercised on his or her behalf by any officer authorised by him or her generally or specifically for the purpose.
- (e) Delegated powers of the Executive Heads, or Chief Planning Officer may be exercised by the Chief Executive in the event of his or her absence

- (f) Delegated powers of any officer:
 - (i) below the level of Service Manager may be exercised by a Service Manager, or by an Executive Head, or Chief Planning Officer or the Chief Executive;
 - (ii) at the level of Service Manager may be exercised by an Executive Head, or Chief Planning Officer or by the Chief Executive;
- (g) The Executive Head of Governance and Regulation may amend any of these delegations to take account of new legislation, amendments to staffing structures, job titles or appointments.
- (h) Those delegations of powers to officers where operational, administrative or legislative changes make the delegation redundant may be deleted
- (i) That where it does not already specify, each delegation also includes any subsequent amendments and re-enactments of legislation in respect of the original delegation already authorised

PROVISIONS RELATING TO DELEGATIONS TO OFFICER FUNCTIONS WHICH ARE THE RESPONSIBILITY OF THE CABINET

- (a) Without prejudice to the Specific delegations to any Officer, the Chief Executive and Executive Heads, or Chief Planning Officer are hereby authorised to make such decisions and initiate such actions as they may deem necessary in the interests of the Council's functions and services.
- (b) Delegation to Officer shall be without prejudice to the rights and powers of the Cabinet or any Sub-Committee of the Cabinet at any time to decide upon any matter.
- (c) In exercising powers, Officer:-
 - (i) shall comply with the Standing Orders and Financial Regulations of the Council;
 - (ii) may authorise expenditure only in accordance with approved estimates which does not require a loan sanction or approval which has not been authorised or received;
 - (iii) shall comply with approved policies, schemes or directions, where they exist; of the Council or any of its Committees; and
 - (iv) shall consult with the appropriate professional or technical officer of the Council.
- (d) Delegated powers of the Chief Executive, or Executive Head, or Chief Planning Officer may be exercised on his or her behalf by any officer authorised by him or her generally or specifically for the purpose.
- (e) Delegated powers of the Executive Heads, or Chief Planning Officer may be exercised by the Chief Executive in the event of his or her absence
- (f) Delegated powers of any officer:

- (i) below the level of Service Manager may be exercised by a Service Manager, or by an Executive Head, or Chief Planning Officer, or the Chief Executive;
- (ii) at the level of Service Manager may be exercised by an Executive Head, or Chief Planning Officer, or by the Chief Executive;
- (g) The Executive Head, Governance and Regulation may amend any of these delegations to take account of new legislation, amendments to staffing structures or job titles or appointments.
